Kin Support

They call her "Ma Dukes" in the neighborhood, and she has raised many generations, despite her health. Ma Dukes has endured several heart attacks and struggles with symptoms of her diabetes. Despite her struggles, she appears strong like a wall of bricks, and she laughs even though she should be crying. Ma Dukes always rolls out the red carpet when her Family Service Coordinator (FSC) arrives at her home. Did I mention she's a strong advocate for her grandchildren?

Here's one story that led to success because of Ma Dukes' advocacy. The FSC was approached one day because Ma Dukes had concerns for her elementary age grandson, Jason, who was in the 4th grade and couldn't read. According to Ma Dukes, Jason would have the other grandchildren complete his school projects or ask for the answers to the questions in his homework assignment. Ma Dukes was confused and not sure why her grandson wasn't on grade level, like all her grandchildren. Ma Dukes said she wasn't used to having a grandchild that needed additional help academically, but reached out to the FSC to locate a tutor who could assist.

Immediately the Kin Support Program FSC was on the case. The FSC reached out to Galaxy Elementary School and gathered information needed to determine what should be done for Jason. The FSC was informed about the School Based Team meeting that would soon take place and determine the level of care the grandson needed. Both the FSC and the grandmother attended the meeting to ensure Jason was receiving the necessary academic accommodations needed in the classroom. Then the FSC received a lead from Galaxy Elementary School staff and reached out to a tutor that provided tutoring for children at the family's local library, at no cost.

Fast forward to today, Ma Dukes raves about how much Jason has improved in his reading level and ability to complete his own homework assignments. Ma Dukes has the ability to attend School Based Team Meetings on her own and communicate her grandson's needs from the skills she learned from the Kin Support FSC. The FSC was also informed that Jason was promoted to the next grade level for the August 2023, school term.

Of the 52 families served through our Kin Support Program, 99% of families enrolled accepted the program services. 99% of the 116 children were able to remain together with relative caregivers and kept out of the welfare system.

For fiscal year ending on September 30, 2023, our seven programs served 1,046 families consisting of 1,694 children/youth and 1,388 adults.



100% of the 401 Families served in our Healthy Families program improved their parenting skills and increased their family stability and selfsufficiency – ultimately eliminating abuse and neglect for the 789 children served by this program.

TOPWA Targeted Outreach for Pregnant Women Act

192 Pregnant, High-Risk Women received a health assessment which consists of HIV testing, substance abuse treatment if needed, and access to prenatal care. 100% of HIV exposed infants tested HIV negative. Behavioral Health Services

Behavioral Health Services served 264 families consisting of 349 children and 516 adults. 85% of children/youth maintained stable behaviors in their home and schools. Of the 10 families served in our Bridges to Success Program, 100% maintained stable housing. 98% of families maintained income including wages and benefits as they continue to work towards self-reliance.



Infant Mental Health

Families First Infant Mental Health program served 37 families, consisting of 82 children and 70 adults. 80% of the caregivers who completed services met their treatment plan reducing the risk of abuse and neglect 100% of the year.

The Child First program served 90 families consisting of 146 children and 128 adults. 80% of the families completed services successfully. Of the families discharged, 100% of those families improved in at least one domain.
